All bidders shall submit a performance security equivalent to 5% of the estimated quantity to be stored at each storage facility at the time of agreement, in the shape of Pay Order or Bank Draft in the name of Director General Food / Cane Commissioner Punjab from any scheduled bank in original.
- 7. In case the date of opening is declared as a public holiday by the government or non-working day due to any reason, the next official working day shall be deemed to be the date of sale and submission and opening of tenders accordingly. The time and venue shall remain the same.
- 8. The bidders are required to give their offers/bids on per maund per month basis (inclusive of all taxes) for wheat stored against EWR., which will be borne by the Government of Punjab for the initial (4) four months.
