Dear,

This letter is to express the intent of the Directorate General of Food to invite bids from eligible organizations for determining operational charges for Electronic Warehouse Receipts (EWRs) services. The services will be utilized for storing commodities under the Electronic Warehouse Receipt (EWR) system, a initiative introduced by the Government of the Punjab to support farmers by providing better returns and protecting them from distress sales of wheat. Under this system, farmers can store their wheat produce in accredited godowns and receive an EWR, enabling them to pledge the receipt to banks for loans or sell their produce at a later date. To be eligible for bidding, your organization must possess the following:

- a. A valid "Accreditation Certificate", issued by a Collateral Management Company (CMC) duly authorized by the Securities Exchange Commission of Pakistan (SECP) under CMC Regulations 2019.
- 2. Given your eligibility, we invite you to submit a bid specifying the operational charges per maund per month inclusive of all the taxes for wheat stored against EWRs. The
