No. ADF-1(Wheat Policy)/2025: In exercise of powers conferred upon me under Section 5(2) of the Punjab Price Control of Essential Commodities Act, 2024 read with notification bearing No. SOR(ICI&SD)1-21/2021(E-1) dated 23.11.2023 and all other enabling provisions, I, NAVEED SHAHZAD MIRZA, DIRECTOR GENERAL FOOD PUNJAB, do hereby fix the Maximum Retail Price of Wheat Flour (Atta) for 10 kg and 20 kg Flour Bags with immediate effect as under:

Wheat Flour	905	1810

This order shall come into force with immediate effect throughout the province and shall remain in force unless and until altered / withdrawn. Packing other than 10 & 20 kg bag shall not be allowed. No Dealer, Wholesale Dealer, Retail Dealer or Retailer shall charge or cause to be charged the Retail Prices of **Wheat Flour (Atta)** offered for sale, in excess of the Rates Fixed and Notified. Each Bag will also be labelled as follows;

- a. Name of the Material
- b. Name and address of the Miller / Manufacturer,
- c. List of Ingredients / Additives
- d. Trade Mark
- e. Average Net Weight
- f. Batch or Code Number
- g. Net Mass in Kg, and
- h. Date of Manufacture and Expiry,
- i. PS: Mark and License number

The product shall be labeled as prescribed in PS:1485 for Labelling of Prepackaged Foods.
